GV Health provides a range of acute, subacute, mental health, aged, primary health and community services across the Goulburn Sub-Region within the Hume Region.

The position will be responsible for cleaning and maintaining the hospital and nursing home to a level of cleanliness that complies with hospital cleaning procedures and aged care accreditation requirements as well as having the ability to provide quality food service and delivery to clients at Tatura Campus to a standard that complies with both Legislative and Quality Assurance requirements during periods of planned/unplanned leave for the permanent part time staff.

# **KEY RESPONSIBILITIES, ACTIVITIES AND DUTIES:**

- Work as part of a client focused team
- Understand reporting lines within the organisation
- Adhere to GV Health policies and procedures
- Ensure full compliance with all regulations relating to environmental and food services
- Carry out duties as per the relevant duty routines or as directed by the person in charge
- When rostered in Cleaning, to be responsible for ordering of linen and other supplies and receival and checking of new stock
- When working in the kitchen, to be responsible for efficient plating of meals, preparation of trays, distribution of meals, collection from service areas and cleaning required after each meal service.
- Provide a high-quality service to internal customers and consumers that reflects best practice and adds value to GV Health
- Assist the organisation in achieving clinical effectiveness by providing the appropriate systems, information or services to clinical areas.
