POSITION SUMMARY

The Hepatitis Clinical Nurse Consultant will be responsible for establishing and continuing an Integrated Hepatitis Service in collaboration with the Department of Health. This service will provide support for people living with Hepatitis C Virus (HCV) in rural communities across the Hume Region.

The role of the Hepatology Clinical Nurse Consultant is central to the delivery of this Service and will provide high-quality professional clinical care, education and support for people living with Hepatitis that are undertaking antiviral treatment. They will promote best practise to other key stakeholders within a shared care model between Specialist, primary care and other key community and hospital-based services, such as Primary Mental Health Teams. They will also provide a consultation role and expert advice to General Practitioners (GP's), mental health and alcohol and drug services and other key networks.

RESPONSIBILITIES AND DUTIES

The following duties are inclusive of but not limited to

Provision and management of nursing care for people with or affected by liver disease, who are undertaking antiviral treatment:

- Lead a nurse-led clinic providing introductory education and assessments for new patients to the GV Health's Hepatology clinic
- Work in collaboration with Specialists, GP's and Nurse Practitioners (NP's) providing care for patients not limited to GV Health
- Engage in comprehensive clinical practice that recognises the needs of people with or affected by Hepatitis throughout the health care continuum
- Intake referral processing for Liver/ Gastroenterology clinic patients



- Clinic template and waiting list monitoring for Liver and Gastroenterology clinics
- Compliance monitoring on the use of the State-Wide Referral Criteria
- Conduct comprehensive, culturally appropriate nursing assessments, including exploration of the
 patient's medical history, drug and alcohol history, mental health history, oral health, social supports
 and environment, use of support services and legal issues
- Provide outreach-coordinated care for patients along the care continuum within scope of practice using evidence-based nursing practice in a variety of settings. This could include specialised settings and community settings such as primary health care clinics
- Provide culturally appropriate and sensitive care to patients from culturally and linguistically diverse (CALD) communities including Aboriginal and Torres Strait Islander communities
- Provide professional and comprehensive counselling for people with or affected by hepatitis
- Advise and assist individuals to manage side effects resulting from treatment
- Facilitates comprehensive outreach and service coordination and follow up of patients who have undertaken treatment and or experienced side effects

Provide expert comprehensive and specialised information about Hepatitis and disease from a nursing perspective to assist people with or affected by Hepatitis; and provide education and support to GP's to increase GP-initiated treatment and management:

- Assess the information and learning needs of people with or affected by Hepatitis
- Provide culturally appropriate information and resources, preferably in plain English or the individuals preferred language
- Demonstrate comprehensive and advanced knowledge of the anatomy and pathophysiology of the liver, the progression of liver disease and the management and treatment of Hepatitis caused by various aetiologies
- Actively seek to extend and evaluate the current body of nursing knowledge and practice as it relates to Hepatology through provision of education to GV Health nursing staff and Regional Nursing staff particularly Primary Nurses based in GP Clinics
- Provide evidence-based information for health professionals and people with or affected by Hepatitis
- Support and clarify information provided by members of the multidisciplinary team
- Maintain up-to-date knowledge of supportive resources for people with or affected by Hepatitis
- Promote new initiatives available from Hepatitis Victoria
- Use advanced communication skills and demonstrate sensitivities when providing information about potentially distressing topics to people with or affected by liver disease
- Develop a management plan in consultation with the patient and the multidisciplinary health care team, considering the information gathered during the nursing assessment
- Incorporate the patient in the development of their management plan and actively encourage them to participate in the decision-making process and to adopt self-management strategies
- Respect the individual's right to make informed choices in relation to treatment, care and subsequent health outcomes
- Explore the individual's evaluation of the health care received and encourages them to provide feedback to their health providers

Contribute to the development, implementation, coordination and evaluation of innovative health care delivery systems that improve the health outcome for people with or affected by Hepatitis:

• Demonstrate advanced knowledge and skills in negotiating a coordinated approach to a shared care model and interdisciplinary care for people with or affected by Hepatitis



- Develop networks with local GP's to provide education, upskilling and engagement in shared care. Visit GP's and provide information for their patients, and present at relevant GP education sessions
- Collect data in accordance with funding and reporting requirements
- Contribute to the evaluation of the impact of the Integrated Hepatitis Service on the health outcomes of people with or affected by liver disease
- Negotiate with and influence key stakeholders to adopt strategic and policy directions related to Hepatitis, such as Rumbalara, Hepatitis Victoria, GP Vic and Sexual Health promotional opportunities
- Develop and maintain effective partnerships with key stakeholders
- Work cooperatively with senior management and peers to gain a commitment to the Integrated Hepatitis service.

Demonstrate an advanced level of knowledge and skills with regard to caring for people with or affected by Hepatitis and actively participate in professional development activities to improve the provision of their clinical care:

- Participate in education programs and ongoing professional development activities in Hepatology and nursing
- Participate in self-directed professional development activities through journals and attendance at Hepatitis conferences through Australasian Society for HIV, Viral Hepatitis and Sexual Health (ASHM) and Australian Hepatitis Association (AHA)
- Demonstrate awareness of relevant clinical, medical and social research developments
- Participate in quality improvement activities to monitor and improve the standard of care provided by Hepatology nurses
- Provide a high-quality service to internal customers and consumers that reflects best practice and adds value to GV Health
- Assist the organisation in achieving clinical effectiveness by providing the appropriate systems, information or services to clinical areas

- Current registration with Australian Health Practitioner Regulation Agency as a Registered Nurse
- Certificate of Nursing Management and Treatment of Hepatitis C and B (ASHM-Australasian Society of HIV Medicine) or equivalent
- Member of the Australian Hepatology Association

Essential:

- Knowledge of diagnosis and broad management of Liver Cancer
- Extensive relevant clinical experience
- Excellent interpersonal, written and communication skills, including computer literacy and the ability to produce well-written reports
- Ability to work effectively both independently and cooperatively within a multi-disciplinary team
- Proven organisational and time management skills with an ability to prioritise and coordinate a diverse workload
- Well-developed understanding and experience in change management processes
- Well-developed understanding of an evidence-based approach to person-centred care



- Satisfactory National Criminal History Check prior to commencement of employment
- Satisfactory Working with Children Check prior to commencement of employment
- Completion of a Commonwealth of Australia Statutory Declaration prior to commencement of employment.

- An interest in liver and gastrointestinal diseases
- Understanding of data entry and patient scheduling systems (iPM/VINAH)
- Demonstrated understanding of the special cultural needs of our diverse community
